Re: Request for Expression of Interest (EOI)

On January 19, 2008 a report by the Canadian Press was released. It was written by Rob Gillies, Associated Press Writer from Toronto. It was called: Canada Manual: US Prisoners Face Torture (Canada Document Lists US, Israel As Countries Where Prisoners Risk Torture, Abuse)

It is a training manual for Canadian diplomats listing the United States as a country where prisoners risk torture and abuse, citing interrogation techniques such as stripping prisoners, blindfolding and sleep deprivation.

There are severe forms of torture in the United States, specifically, the State of California. It is worse than stripping prisoners, blindfolding and sleep deprivation. Some of the techniques the U.S. Government executed on me are displayed at <http://kinispolarbear.bravehost.com> where this author has managed to survive so far.

Reported to all levels of state and federal courts in this jurisdiction including the Federal Claims Court in Washington, DC, my claims remain ignored, damages unaccountable, and a \$100k trust estate taken by Jews <http://appeals4justice.zoomshare.com>.

I have suffered violations of human rights that include basic dignity care, failures to provide access to courts and appeals, tyranny, extremism, intolerance, and violence, crimes against humanity and other mass human rights violations, and severe forms of discrimination: Rights that have become eroded in the name of national security. As a result, my treatment has become a harbinger of wider-scale repression.

So, not only do you report in your manual Guantanamo Bay, Israel, Afghanistan, China, Egypt, Iran, Saudi Arabia, Mexico and Syria as places where inmates could face torture, but the United States in all its pride refuses to acknowledge that we have torture and abuse tactics right here in this country.

U.S. Ambassador David Wilkins told the Associated Press that the U.S. does not authorize or condone torture. "We think it should be removed and we've made that request. We have voiced our opinion very forcefully," Wilkins said.

Michael Mendel, the Israeli Embassy spokesman, said Israel's Supreme Court "is on record as expressly prohibiting any type of torture. If Israel is included in the list in question, the ambassador of Israel would expect its removal," he said.

After that OTTAWA (Reuters) reported: Canada's foreign ministry, responding to pressure from close allies, said on Saturday it would remove the United States and Israel from a watch list of countries where prisoners risk being tortured. Foreign Minister Maxime Bernier said he regretted the embarrassment caused by the public disclosure of the manual, which also classified some U.S. interrogation techniques as torture.

This author has managed to compile dossiers expressing incidents how adjudicators have flouted international law and their own guidelines. The principle aim is to reveal the most organized and efficient way possible using repression and discrimination while being criminalized.

Survival for this author has become a form of resistance to the Department of Justice (DOJ); state and federal courts and police departments because of one woman's sexual orientation. She is being governed as inferior and an economic burden.

It remains a dilemma to know whether they specifically hate this woman and enjoy terrorizing her into submission, or whether they are ordinary people caught up in the evil of the police regime. To date, my claims of grand theft larceny, asset freezes, or disappearances of a **\$100k rightfully inherited trust estate** remains unreturned to its rightful owner.

Violence Against Women

When will we recognize what is happening to the underprivileged who are being trafficked in the United States today? When will we have the courage to care?

Must we continue to break a woman down so that a woman can no longer perform useful work because she had dreams and hopes one can reasonably expect of life?

How long should we continue to beat her into submission by verbal abuse and through the use of other repressive tactics?

Is it more humane to rob her of a family at any costs and discard her on the street?

Is it more economical to continue to use psychological warfare and banter a woman with insanity to undermine her qualities.

Shall we render her credibility useless, instead of being held accountable to pay out damages?

Should we use verbal abuse to make the woman feel inferior hoping she will submit to the whims of strange men?
